It shall be the responsibility of the stallholder to arrange all relevant insurance not including public liability which will be covered by the Feast Festival.
2. Feast Festival reserves the right to be the sole supplier/contractor of alcoholic beverages and non alcoholic beverages. **The sale or provision of alcoholic beverages and soft drinks and water is strictly prohibited.**
3. Feast reserves the right to allocate more than one vendor the sale and distribution of certain retail items.
4. Feast reserves the right to be the sole seller of raffles, collections and merchandise outside of stall sites. If you are running a raffle or collection from your stall you must seek approval from Feast.
5. Feast Festival reserves the right to refuse any application. Fees are **non refundable** after **Friday 28th October 2010.**
6. Feast Festival reserves the right to refuse late applications, however, if an application is accepted, it is dependent on there being sites available and that some specific requests may not be able to be met.
7. Feast Festival reserves the right to refuse requests on the day of the Sale (eg. additional space, signage, etc.)
8. Stallholders accept responsibility for setting up and clearing their stall space and surroundings, including the removal of all waste and recycling.
10. Stallholders agree to abide by the instructions of Feast Management, SA Police and Adelaide City Council Officials, Office of Liquor Licensing & Gaming, and Worksafe SA Inspectors.

**ARRIVAL AT LIGHT SQUARE**

1. The Square will open to stall holders from 9am. Stallholders will have a one hour window to unload equipment/merchandise etc. All cars must be removed from the square by 10am.
2. Deliveries to your stall must not occur before the arrival time on the day. **NO EXCEPTIONS.**
3. Entry on to Light Square will be determined closer to the event. Feast will contact all stallholders to discuss how to access Light Square well before the event.
4. On arrival, a Feast Official will direct you to your stall.

**DURING THE COMMUNITY EXPO**

1. Hours of operation will be between 12pm and 5pm.
2. Stall Holder vehicles will not be permitted back onto the Square during the event.

**END OF THE DAY**

1. Vehicle access at the end of the day will not be allowed until 5pm and will only occur until 5:45pm.
2. Vehicles are not permitted to queue on the roads around Light Square before this time.
